MESSAGE FROM THE **BOARD PRESIDENT**

It's been a special year to serve as the president of the Gateway Domestic Violence Center Board of Directors. Gateway was founded 40 years ago, and it's been truly inspirational to look back at where this nonprofit started – with a handful of dedicated women and community allies who saw a critical need – and to realize just how much we've grown.

When Gateway launched its capital campaign six years ago, I had not yet joined the board. Through my job in commercial real estate, I had the opportunity to work with the organization's leadership to identify properties from raw land to existing buildings that might be suitable for Gateway's new shelter.

It was during this process I learned so much more about the organization and the critical services they provide in our community. I was honored to help Gateway find its new home and, ultimately, to come on board and contribute in any way that I could.

Like most real estate clients, Gateway had a list of features that were musts and a few others that were considered important but not deal breakers. After an extensive search that took us to all kinds of properties, we found a site that enabled Gateway to check everything off their list:

Located in the City of Gainesville

Near public transportation

✓ Safe area

Room for future growth (the new site has 5+ acres)

On city sewer

Employment opportunities for clients

Gateway's campaign committee originally selected a tagline for the capital project: "Building Foundations. Securing Hope." I'm excited to say that's just what we've done. The foundation for our brand new shelter has been poured and builders are putting the finishing touches on the beautiful space as I write this.

The organization's future is secure, thanks to the generosity of our supporters. Due to the support of individual donors, foundations, business, churches and grants, we will open the shelter this summer debt-free, having blown past our \$4.5 million campaign goal.

Gateway always had provided hope to survivors of domestic abuse. But this new shelter represents something more – a place built with them in mind. A temporary home offering safety, healing and the promise of a brighter future.

Thank you for joining us on this journey. I know I can't wait to see what Gateway is able to accomplish over the next 40 years!

TASK FORCE RECEIVES STATEWIDE RECOGNITION

Janet Whittaker, Gateway shelter manager, presented at the 2021 Georgia Commission on Family Violence (GCFV) Conference. Janet shared information about the Hall County Domestic Violence Task Force's responses to incidents of domestic violence-related murder-suicide incidents. Task force members have spent hours meeting with surviving family members, providing information about victims' compensation, and gathering required documents. They also have made counseling referrals and advocated for services needed by survivors.

Hall County saw a surge in incidents of family violence-related deaths in 2021. According to GCFV, Hall County saw an average of 2.4 deaths related to family violence per year from 2013-2017 (the most recent five years the Georgia Domestic Violence Fatality Review reports were published). In 2021, Hall County experienced 9 family violence-related deaths and two critical injuries associated with these fatalities.


During the GCFV conference, the Hall County Domestic Violence Task Force was named the "Domestic Violence Task Force of the Year."



DISCUSSION GROUPS HIGHLIGHT SURVIVORS' FINANCIAL STRUGGLES

The series MAID topped the Netflix charts at the end of 2021. The series focused on a mother who fled an abusive relationship and struggled to provide for her child. Gateway developed a discussion guide and hosted four discussion groups based on this series. In addition to hosting local events, Gateway shared the curriculum with other organizations throughout the US and Canada. GATEWAY BY THE NUMBERS

IN 2021...

- 192 women and children lived
- 79 people were placed in a hotel for some or all of their emergency shelter stay because there was not enough space in the shelter
- **17** average number of people in the 18-bed emergency shelter
 - 33 average length of stay in the emergency shelter

- 6,216 guest nights of shelter were provided in the emergency shelter
- 52 women and children lived in Gateway's long-term transitional housing program
- **17** average number of months residents lived in the transitional housing program
- **8,754** guest nights were provided in the transitional housing program
 - \$11.35 average hourly wage of transitional housing residents
- 1,453 total number of clients served - both residential and nonresidential

- 2,168 number of crisis calls Gateway answered on the 24/7 hotline
- 91% of the adults who participated in Gateway programs said they can better manage their own safety
- **116** Temporary Protective Orders were secured
 - 102 adult survivors of abuse participated in support groups
- **128** children participated in support groups and educational programs

Gateway House opens; providing services 24 hours a day, every day, since opening – more than 14,000 consecutive days.



1984

Children's Program starts; has served children and teens continuously since.

2001

A significant facility expansion, including the addition of three on-site transitional apartments, is completed.



2002

First Gateway
Thrift Store opens.

2008

Receive the Medical Center Foundation Golf Tournament proceeds (\$201,565) which are used to add dedicated support group space for children and teens. 2011

The "Power of We" \$1 million capital campaign begins, aiming to raise funds for Transitional Housing expansion.

2015

Construction of seven Transitional Housing Apartments is completed debt-free.



1985

Gateway moves into a new shelter provided by the City of Gainesville; it's the first domestic violence shelter in Georgia to be designed and built specifically as a shelter for battered women.

1992

First expansion of the Gateway shelter.

1997

Gateway's Legal Advocacy program begins, and within two years a second legal advocate is added.

1995

Gateway begins offering bilingual services and support groups.



2016

The Gateway Board of Directors launches the "Gateway to 2020, Building Foundations – Securing Hope" capital campaign to raise funds for construction of a new shelter.



2021

Construction begins on the new shelter.
